Terbutaline

(ter-**byoo**-ta-leen)

Category: Bronchodilator

Other Names for this Medication: Brethine®

Common Dosage Forms: Veterinary: None. Human: 2.5 mg & 5 mg tablets; 1 mg/mL injection.



This information sheet does not contain all available information for this medication. It is to help answer commonly asked questions and help you give the medication safely and effectively to your animal. If you have other questions or need more information about this medication, contact your veterinarian or pharmacist.

Key Information

- ▶ Terbutaline can increase heart rate and cause excitement.
- ▶ This drug can delay labor in pregnant animals.
- Overdoses can be serious; keep well out of reach of children and animals.

How is this medication useful?

Terbutaline can be used in animals for relief of problems related to asthma and other respiratory conditions. This drug can also be used to treat premature labor, slow heart rate, and, when injected in horses, to diagnose a condition known as anhidrosis (unable to sweat enough).

The FDA (U.S. Food & Drug Administration) has approved this drug for use in humans, but it is not officially approved for use in animals. The FDA allows veterinarians to prescribe products containing this drug in different species or for other conditions in certain situations. You and your veterinarian can discuss why this drug is the most appropriate choice.

What should I tell my veterinarian to see if this medication can be safely given?

Many things might affect how well this drug will work in your animal. Be sure to discuss the following with your veterinarian so together you can make the best treatment decisions.

- Other drugs can interact with terbutaline, so be sure to tell your veterinarian and pharmacist what medications (including vitamins, supplements, or herbal therapies) you give your animal, including the amount and time you give each.
- ► Tell your veterinarian about any conditions or diseases your animal may have now or has had in the past.
- ▶ If your animal has been treated for the same disease or condition in the past, tell your veterinarian about the treatment and how well it did or didn't work.
- ▶ If your animal is pregnant or nursing, talk to your veterinarian about the risks of using this drug, as terbutaline can delay labor.
- ► Tell your veterinarian and pharmacist about any medication side effects (including allergic reactions, lack of appetite, diarrhea, itching, hair loss) your animal has developed in the past.

When should this medication not be used or be used very carefully?

No drug is 100% safe in all patients, but your veterinarian will discuss with you any specific concerns about using this drug in your animal.

This drug **SHOULD NOT** be used in patients:

That are allergic to it.

This drug should be used **WITH CAUTION** in patients:

- With irregular heartbeats or heart disease as it can cause the heart to beat too fast.
- With diabetes, excessive thyroid hormone (hyperthyroidism), high blood pressure, or seizures (eg, epilepsy).

If your animal has any of these conditions or signs, talk to your veterinarian about the potential risks versus benefits.

What are the side effects of this medication?

Common, but not serious side effects include:

 Slightly faster heart rate (heartbeat) and trembling or excitement.

You don't have to be overly concerned if you see any of these signs unless they are severe, worsen, or continue to be a problem. Contact your veterinarian if this happens.

Side effects that may be serious or indicate a serious problem include:

 Weakness, less energy, rapid breathing, excessive panting (in dogs), threatening behavior, agitation (eg, anxious, nervous, upset, unable to relax), and vomiting.

Contact your veterinarian immediately if you see any of these signs, as it may mean the dose is too high.

If my animal gets too much of this medication (an overdose), what should I do?

Overdoses of terbutaline can be serious. If you witness or suspect an overdose, immediately contact your veterinarian or an animal poison control center for further advice. Animal poison control centers that are open 24 hours a day include: **Pet Poison HELPLINE** (855-764-7661) and **ASPCA Animal Poison Control Center** (888-426-4435); a consultation fee is charged for these services.

How should this medication be given?

For this medication to work, give it exactly as your veterinarian has prescribed. It's a good idea to always check the prescription label to be sure you are giving the drug correctly.

- ► Liquid forms of this medication must be measured carefully. Your veterinarian or pharmacist can help by providing special measuring spoons or syringes.
- ▶ If you have difficulty getting your animal to take the medicine, contact your veterinarian or pharmacist for tips to help dosing and reducing the stress of medication time.
- This medication can be given for various lengths of time. Be sure you understand how long your veterinarian wants you to continue giving this medication. Prescription refills may be necessary before the therapy will be complete. Before stopping this medication, talk to your veterinarian, as there may be important reasons to continue its use.



What should I do if I miss giving a dose of this medication?

If you miss a dose, give it when you remember and then wait the amount of time between doses recommended by your veterinarian before giving another dose. Do not double-up or give extra doses.

How should I store this medication?

- Store this medication in the original prescription bottle or an approved dosage reminder container (ie, pill minder) at room temperature, out of direct sunlight.
- ▶ Keep away from children and other animals.

Can handling this medication be hazardous to me, my family, or other pets?

There are no specific precautions required when handling this medication unless you are allergic to it. Wash your hands after handling any medication.

How should I dispose of this medication if I don't use it all?

- ▶ Do not flush this medication down the toilet or wash it down the sink. If a community drug "take-back" program is available, use this option. If there is no take-back program, mix the drug with coffee grounds or cat litter (to make it undesirable to children and animals and unrecognizable to people who might go through your trash), place the mixture in a sealable plastic bag to keep it from leaking out, and throw the bag out with the regular trash.
- Do not save left over medication for future use or give it to others to use.

What other information is important for this medication?

Use of this drug may not be allowed in certain animal competitions. Check rules and regulations before entering your animal in a competition while this medication is being administered.
